Tenement Management

Advertising	NSW and VIC have specific requirements and processes for advertising new applications in both state and local newspapers.
Applications	Preparation of applications which can include drafting maps, work programs, environmental and community consultation programs, lodging all documentation and liaising with government departments.
Dealings (including joint ventures)	AMETS can take care of all matters relating to dealings, including but not limited to caveats, the registration of joint venture agreements and the registration of agreements.
Landowner Liaison	AMETS can liaise and correspond with all landowners who are related to your project. This includes land access, compensation, negotiation, and department discussions.
Native Title	All matters relating to native title, including compensation, department correspondence and liaising with affected parties.
Objections	Dealing with objections to applications received from landowners or the public.
Planning Permits	Preparation, lodging and amendments to planning permits.
Renewals	Includes preparation and lodgment of renewal applications with the assistance of supporting documentation from the client.
Transfers	AMETS can liaise with all parties and Government departments to ensure the transfer processes smoothly until completion.
